## Rotaract club of Sabarmati teams up with Rummy Circle

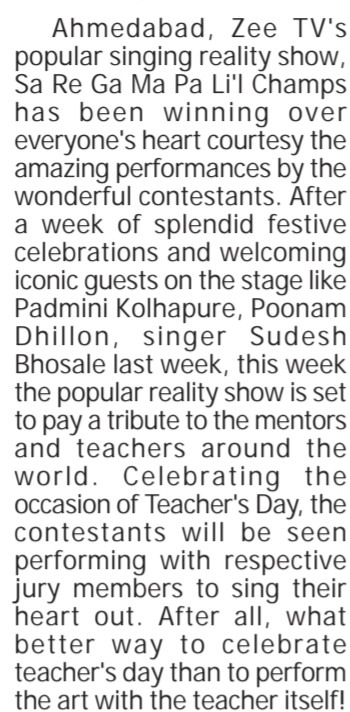

## GST revenue loss: Karnataka decides to choose first option offered by Centre

Bengaluru, Karnataka has indicated its preference for the first option offered by the Centre to offset GST revenue losses under which it is expected to get Rs 18,289 crore including Rs 6965 crore from cess collected. The rest Rs 11,324 crore, it would be able to borrow through a special window from RBI with the full burden of principal and interest being borne of the cess fund to be collected in future. The decision was taken after chief minister BS Yediyurappa met senior officials of the state finance department according to a statement from his office.
