Patan-Palanpur, More than 50 people got jobs in private companies by making fake mark sheets from the original ones. Young men who are passionate about oil are working in a private company that extracts oil from ONGC.

Not just two such young men, but many others are

working in the company by making fake mark sheets. If an investigation is conducted, a major scam may be uncovered. Tejas Rawal/Naresh Chauhan In the mark sheets given to students studying in colleges in North Gujarat affiliated to Hemchandracharya University, without the knowledge of the

student, the name of the failing or illiterate youths is changed and their mark sheets are made by changing their names. The youths are working in private companies that extract oil from ONGC. The investigation team has revealed that two youths have changed the names in the correct mark sheets of two

students who studied at the university in the year 2017/18 and are using their fake mark sheets to get jobs and create fake degrees.
